6. Attached are the following enclosures for your reference: General Management, Technical Management, Regional Technical Working Group, and General Guidelines.

7. Expenses such as meal allowance, transportation and other incidental expenses by the officiating officials, tournament managers, regional screening and accreditation committee, and SRAA technical staff incurred relative to and during the conduct of 2024 SRAA Meet shall be charged to local funds (LGU/PTA) and MOOE subject to the usual accounting and auditing rules and regulations.

8. Since the schedule of 2024 SRAA Meet falls on school days, concerned schools are enjoined to adopt measures to ensure that NO classes of teachers involved in the regional meet are left unattended. Schools are encouraged to follow schemes such as distribution of learners to different sections in the meantime that the teacher/s is/are out for the training, assigning other teacher or the school head to handle classes, or other strategies most applicable and beneficial to the learners. SDO should closely monitor the implementation of these measures and provide the necessary technical assistance to schools to make sure that classes are not disrupted.

9. The participants shall be entitled to Compensatory Time-off (CTO) in accordance with CSC and DBM Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Service Rendered for non-teaching personnel, and service credits for teaching personnel pursuant to the provisions set under DepEd Order No. 53, s. 2003, entitled Updated Guidelines on Grant of Vacation Service Credits to Teachers.

General Guidelines

1. Measurable sports such as athletics, swimming, and archery, shall apply the Qualifying Standards (Time & Distance) provided by the Palarong Pambansa Secretariat (PPS).
2. In case of tie, the following shall be applied:
 - 2.1 triple tie – point quotient system
 - 2.2 double tie – win over the other
3. All ball games will be played by bracket thru draw lots.
4. Team sports shall apply the “Winner Take All” policy (DM No. 005, s. 2023).
5. Archery and billiard elementary (boys & girls) shall be played in 2024 SRAA Meet as “Demonstration Sports”.
6. Running medal tally shall be used in determining the performance of SDOs in 2024 SRAA Meet.
7. Top three athlete/s or team in every sport event shall be awarded with medal (gold, silver, & bronze), while coach/es will receive a Certificate of Commendation.
8. Top three SDOs in the overall results of every sports discipline shall be awarded with a Certificate of Recognition.
9. Announcement of winner shall follow the prescribed format/sequence: name of sports event, name of athlete/s or team, name of school, name of city/municipality, and name of SDO.
10. May 11-12, 2024, interview of PARA Games athletes.
11. After the competition, Tournament Manager shall submit the following documents to the technical staff, to wit;
 - 11.1 Technical Officials’ attendance sheet,
 - 11.2 Over-all ranking of results,
 - 11.3 List of recommended athletes, coaches and chaperons, and
 - 11.4 2024 SRAA Meet Clearance for Tournament Manager.
12. Protest on the eligibility of coach, and athlete shall be referred to the Regional Screening and Accreditation Committee (RSAC), while protest on the technicality of the game shall be referred to the Jury of Appeals.

13. Only the official coach of the team can file a written protest, and shall be signed by the Head of the Delegation. Absence of the signature of the Head of the Delegation, written protest shall not be entertained.
14. Protest fee shall be PhP 5,000.00 non-refundable.
15. Replacement of athlete/s after the 2024 SRAA Meet shall be based on the ranking submitted by the Selection Committee, likewise, law of succession shall be applied in case of a coach, assistant coach, and chaperon waive his/her right to coach/participate in the 2024 Palarong Pambansa.
16. Recommended athletes for 2024 Palarong Pambansa shall undergo scrutiny/validation by the Regional Selection Committee.
17. Official list of selected athletes, coaches, and chaperons for 2024 Palarong Pambansa shall be announced through a Regional Memorandum.
