## GUIDELINES ON THE UTILIZATION OF FY 2024 HUMAN RESOURCE DEVELOPMENT (HRD)- INSET FUND AND PSF

To: Schools Division Superintendents All Others Concerned

1. In reference to DM-OUHROD-2024-0427 re Guidelines on the Utilization of FY 2024 Human Resource and Development (HRD) Fund, all Schools Division Offices (SDOs) are directed to strictly adhere to the guidelines on the utilization of HRD Funds, both for In-service Training (INSET) and Program Support Fund (PSF), set by this memorandum.

2. The funds are intended for the conduct of programs, projects, and activities (PPAs) geared towards the continuing Professional Development (PD) of personnel in schools and learning centers. The utilization of funds shall be in accordance with the provisions of DepEd Order No. 030, s. 2021 titled *Multi-year Implementing Guidelines* on the Allocation and Utilization of the Human Resource Development Fund for Teachers and School Leaders.
