#### 2024 SOCCSKSARGEN REGIONAL ATHLETIC ASSOCIATION (SRAA) MEET

May 13-17, 2024

General Santos City

#### General Guidelines

- 1. Measurable sports such as athletics, swimming, and archery, shall apply the Qualifying Standards (Time & Distance) provided by the Palarong Pambansa Secretariat (PPS).
- 2. In case of a tie, the following shall be applied:
  - 2.1 triple tie point quotient system
  - 2.2 double tie win over the other
- 3. All ball games will be played by bracket through draw lots.
- 4. Team sports shall apply the "Winner Take All" policy (DM No. 005, s. 2023).
- 5. Archery and billiard elementary (boys & girls) shall be played in the 2024 SRAA Meet as "Demonstration Sports".
- 6. The running medal tally shall be used in the determination of the performance of every SDO's during the 2024 SRAA Meet.
- 7. The top three athlete/s or teams in every sports event shall be awarded a medal (gold, silver, & bronze), while the coach/es will receive a Certificate of Commendation.
- 8. The top three SDOs in the overall results of every sports discipline shall be awarded with a Certificate of Recognition.
- Announcement of the winner shall follow the prescribed format/sequence: name of sports event, name of athlete/s or team, name of school, name of city/municipality, and name of SDO.
- 10. May 11-12, 2024, interview of PARA Games athletes.
- 11. After the competition, the Tournament Manager shall submit the following documents to the technical staff, to wit;
  - 11.1 Technical Officials' attendance sheet,
  - 11.2 Overall ranking of results,
  - 11.3 List of recommended athletes, coaches, and chaperons, and
  - 11.4 2024 SRAA Meet Clearance for Tournament Manager.
- 12. Protest on the eligibility of coach, and athlete shall be referred to the Regional Screening and Accreditation Committee (RSAC), while protest on the technicality of the game shall be referred to the Jury of Appeals.

- 13. Only the official coach of every team can file a written protest and shall be signed by the Head of the Delegation. Absence of the signature of the Head of the Delegation, written protest shall not be entertained.
- 14. The protest fee shall be Ph5,000.00 non-refundable.
- 15. Replacement of athlete/s after the 2024 SRAA Meet shall be based on the ranking submitted by the Selection Committee, likewise, the law of succession shall be applied in case of a coach, assistant coach, and chaperon waive his/her right to coach/participate in the 2024 Palarong Pambansa.
- 16. Recommended athletes for 2024 Palarong Pambansa shall undergo scrutiny/validation by the Regional Selection Committee.
- 17. The official list of selected athletes, coaches, and chaperons for 2024 the Palarong Pambansa shall be announced through a Regional Memorandum.
