**ONLINE ORIENTATION ON SCHOOL GOVERNANCE COUNCIL ENHANCED  
FUNCTIONALITY ASSESSMENT TOOL**

To: Schools Division Superintendents

1. In 2022, the Bureau of Human Resource and Organizational Development – School Effectiveness Division (BHROD-SED) developed an assessment tool that aimed support the implementation of DepEd Order 26, s. 2022 or Implementing **Guidelines on the Establishment of School Governance Council (SGC)**. This tool initially assessed SGC’s functionality using the indicators provided in the mentioned policy using the online platform (google link). However, on March 8, 2024, DepEd google accounts temporarily suspended its services resulting to the interruption of submission and validation of SGC functionality. To address the issue, DepEd BHROD-SED duplicated the tool and transferred to a larger storage account.
