

- 1. Evaluate the lesson scripts for the National Reading Program, National Mathematics Program, and Catch-up Fridays in all grade levels across all learning areas immediately upon the approval of the Memorandum of Agreement.
- 2. Divulge personal information and sign an oath of commitment to ensure the identified individuals have no conflict of interest.
- 3. Report consistently and update the DepEd on the quality assurance progress of the lesson scripts for the National Reading Program, National Mathematics Program, and Catch-up Fridays in all grade levels across all learning areas.
- 4. Maintain the confidentiality of all information arising out of or as a result of the work and shall not disclose or permit disclosure of the lesson scripts for the National Reading Program, National Mathematics Program, and Catch-up Fridays in all grade levels across all learning areas and other information acquired from DepEd, directly or indirectly, during its undertaking or at any time after that without proper authorization from DepEd.

Attend orientation sessions and in-person writeshops on the development and quality assurance of the lesson scripts for the National Reading Program, National Mathematics Program, and Catch-up Fridays in all grade levels across all learning areas.
