DELIBERATION AND FINALIZATION OF THE VALIDATED DRAFT MANUAL OF PROCEDURES FOR SCHOOL CLINICS

To: Schools Division Superintendent Division of Cotabato

1. The Bureau of Learners Support Services-School Health Division (BLSS-SHD) is in the final stage of the development of the Manual of Procedures (MOP) for School Clinics.
