1. In reference to Regional Memorandum ESSD – 2024-033, dated March 11, 2024 and Pursuant to DepEd Order No. 23, s.2015 titled Student-led School Watching and Hazard Mapping, and DepEd Order No. 37, s.2015 or the Comprehensive DRRM in Basic Education Framework, this office shall conduct **BATANG EMPOWERED RESILIENT (BERT) TEAM DIVISION TRAINING OG TRAINERS 2024** on July 16-18, 2024 (live-in), Venue: TBA thru official GC.
