**AUGMENTATION OF MEDICAL PERSONNEL FOR PALARONG PAMBANSA 2024**

To: Schools Division Superintendents

1. Pursuant to Region Memorandum ESSD-2024-093, which pertains to the **ASSIGNMENT OF MEDICAL PERSONNEL FOR PALARONG PAMBANSA 2024**, the various SDOs have been asked to provide a minimum of two (2) medical personnel to supplement the existing medical team.

2. The following medical personnel are additional to and shall be included in the 2024 Palarong Pambansa Medical Team:

3. They will be dispatched to various groups to provide assistance at the medical clinic and patrol the numerous locations, ensuring the well-being and safety of all participants in Palarong Pambansa 2024, including athletes, coaches, chaperones, and the technical and logistics team.

4. Accommodation (Medic quarters) will be announced by the host city after orientation of all the medical teams from different regions.

5. The medical personnel are provided with medicines, some basic medical apparatus (e.g glucometer, digital BP apparatus, thermometer, etc.) and basic protective gear (e.g mask and gloves) for their safety and convenience. Proper endorsement of cases (seen and needs follow up) is expected from Outgoing Medical Team and will be received by the Incoming Medical Team for continuous care.

6. Compensatory Overtime Credits may be availed of by the personnel for services rendered on dates that fall on a holiday or non-working holiday in accordance with DepEd Order No.30, s 2012 or the Policies and Guidelines on Overtime Services and Payments in the Department of Education.

7. Traveling and incidental expenses shall be borne from their respective Division MOOE, subject to the usual accounting and auditing rules and regulations.
