## ADMINISTRATION OF THE RAPID MATHEMATICS ASSESSMENT (RMA), COMPREHENSIVE LITERACY ASSESSMENT (CRLA) FOR GRADES 1 TO 3 FOR THE BEGINNING OF THE SCHOOLYEAR 2024-2025

1. In reference to DM-CT 284-2024 titled on 2024 Administration of the Rapid Mathematics Assessment (RMA), Comprehensive Literacy Assessment (CRLA) for Grades 1 to 3 of the School Year 2024-2025, the Rapid Mathematics Assessment (RMA) and Comprehensive Literacy Assessment (CRLA) for Grades 1 to 3 shall be administered nationwide by the beginning of School Year 2024-2025, thus, ensuring the conduct of the assessment to all schools of South Cotabato Division.

2. The RMA and CRLA are scheduled for administration from **September 2 to 13, 2024**. The CRLA and RMA shall be administered as follows:

- 1. Grade 1 assessment tools for learners currently enrolled in Grade 1;
- 2. Grade 2 assessment tools for learners currently enrolled in Grade 2; and
- 3. Grade 3 assessment tools for learners currently enrolled in Grade 3;

3. School Coordinators/Teacher Advisers are requested to record the learners results in the scoresheets provided. School Heads shall ensure that the school summaries are promptly uploaded to the submission provided below as soon as all learners are assessed not later than September 13, 2024.
