ADMINISTRATION OF THE PRETEST OF THE REVISED PHILIPPINE INFORMAL  
READING INVENTORY (PHIL-IRI) AND COMPREHENSIVE LITERACY ASSESSMENT  
(CRLA) FOR SCHOOL YEAR 2024-2025

1. In reference to RM-CLMD-2024-294 DM-CID NO. 196, S. 2024 titled Administration of the Pretest of the Revised Philippine Informal Reading Inventory (Phil-IRI) and Comprehensive Literacy Assessment (CRLA) for the School Year 2024-2025, to learners in public elementary schools division wide.
2. The Phil-IRI and CRLA pretest results shall be submitted to our **Division Link** and be forwarded through our group chat of District Filipino Coordinators on or before **September 15, 2024** while the post -test shall be submitted on **May 2, 2025**.
3. The schools may use a validated and contextualized reading assessment tool to assess and gather data on students' reading levels, particularly in terms of slow readers and non-readers for Grade 7-10.
4. Furthermore, the District/School Reading Coordinators and School Heads shall ensure that the summary of CRLA results is encoded and submitted through **<https://bit.ly/CRLASchoolSubmission>** and to track and monitor the progress of CRLA submissions, the results may be accessed through the link: <https://bit.ly/NationalCRLASubmissionMonitoring>.
