Schools are encouraged to follow schemes such as the distribution of learners to different sections, assigning other teachers or the school head to handle classes, or other strategies most applicable and beneficial to the learners. School head should closely monitor the implementation of these measures and make sure that classes are not disrupted.

For services rendered on Saturday and Sunday, all personnel concerned are entitled to Compensatory Time Off (CTO) or Service Credits per Civil Service and DBM Joint Circular No. 2, s. 2004 on **Non-Monetary Remuneration for Overtime Service Rendered** or DO 53, s. 2003 on **Updated Guidelines on Grant of Vacation Service Credits to Teachers**.

6. Food allowance, transportation and other incidental expenses incurred by the participants relative to and during the conduct of the activity shall be charged against School MOOE and other local funds subject to the usual accounting and auditing rules and procedures.
