- i. In reference to DepEd Memorandum BEA-2024-07-933 titled, Administration of the National Learning Camp Assessment (NLCA), the NLCA Post-Test shall be conducted to all incoming Grades 8, 9, 10, and 11 learners of SY 2024-2025 from July 22, 2024, to August 2, 2024.
- 2. This activity aims to evaluate the learning achievement of learners who participated in the 2024 National Learning Camp (NLC).
- 3. The learners who will be qualified to take the NLC post-test should have participated in the NLC and took the pre-test. The list of qualified test-takers shall be sent via official group chat of school testing/ICT coordinators.
- 4. School Information and Communication Technology (ICT) Coordinators are instructed to check and update the DepEd Microsoft email addresses of all eligible NLC test-takers to ensure that the learners have correct login credentials in the DepEd Learning Management System platform.
- 5. The Division Information Technology Officer (DITO) and the Division Testing Coordinator (DTC) shall conduct onsite visitation to the testing centers from July 18, 2024, to August 2, 2024, to provide technical assistance in the preparation and administration of NLCA.
- 6. Public Schools District Supervisors (PSDSs), Principals In-Charge (PICs), and Secondary Cluster Heads are tasked to monitor and ensure that all concerns and issues relative to the administration of the tests are resolved immediately.
- 7. Meal allowance of the testing personnel shall be charged against the Program Support Fund (PSF) while travelling and other incidental expenses incurred during the conduct of the said examination shall be charged against local
