ONLINE ENCODING OF FINANCIAL PLAN (FP) FOR FISCAL YEAR (FY) 2025

- 1. The Department of Budget and Management (DBM) has released the Fiscal Year (FY) 2025 National Expenditure Program (NEP) formulated within the overarching theme of "Agenda for Prosperity: Fulfilling the Needs and Aspirations of the Filipino People" to achieve a meaningful national development and institutionalized specific programs and projects aimed at pursuing opportunities for accelerating economic recovery and post recovery development.
- 2. Anent this, all schoolheads of public elementary, integrated, and secondary schools including implementing units are directed to convene their respective School Planning Team (SPT) in crafting the fourth cycle of the School Improvement Plan (SIP) for FY 2025-2027 and Annual Improvement Plan (AIP) for FY 2025 based on the FY 2025 NEP.
- 3. Further, all schoolheads are directed to encode their FY 2025 Financial Plan (FP) by quarter at https://bit.ly/SDSCFY2025NEP. The online encoding is now open and shall be closed on October 1, 2024.
- 4. The following guidelines shall be strictly observed in the encoding of the FY 2025 FP by quarter.
 - a. Use only the sheet provided for the encoding of quarterly disbursement program i.e. Elementary, Junior High School, and Senior High School;
 - b. The spreadsheets shall not be altered. Adding sheets and deleting rows or columns shall not be allowed;
 - c. The total MOOE in the four quarters must be equal to the total MOOE based on the NEP;

- d. The amount is already expressed in thousands. Hence, adding three zeroes shall not be allowed.
- e. The amount shall be in full thousand per quarter. Hundreds are not allowed e.g. 20.5 instead of 20,500.
- 5. The FY 2025 FP prepared and encoded in the online spreadsheet by the schoolheads shall be used by the Budget Section in the preparation of the Budget Execution Documents (BEDs) to be submitted to the DBM.
- 6. Three copies of the following financial documents shall be submitted to the office of the School Governance and Operations Division (SGOD) on or before October 15, 2024.
 - a. Hardcopies of the FY 2025 FP;
 - b. School Operating Budget (SOB) printed in a legal-sized white bond paper; and
 - c. Obligation Request and Status (ORS) printed in legal-sized yellow bond paper.
