**REITERATION OF PERSONNEL REGISTRATION FOR PHILHEALTH KONSULTA
IMPLEMENTATION**

1. PhilHealth Konsultasyong Sulit Tama (Konsulta) is a comprehensive outpatient benefits as mandated by the Universal Health Care Law (UHC). Its aim is to ensure that all Filipinos have equitable access to quality and affordable health care goods and services, and are protected against financial risks.
2. It also aims to protect the health of every Filipinos against chronic illnesses, avoid complications through early detection and to provide affordable drugs and medicines. Under the PhilHealth Konsulta, all Filipinos shall be registered with an accredited Konsulta Provider of their choice and be eligible for the consultation, health risk screening and assessment, selected laboratory and diagnostic test, and selected drugs and medicines.
3. This division aims to ensure that all employees, including job order personnel are registered, their data is updated, and they are included in the list of those eligible to avail the package.
4. To avail this package, this office, in coordination with Local Philhealth Office, shall assist all members in updating their Konsulta registration. The SDO Functional Divisions and all schools are required to accomplish the MS Excel template attached to this memorandum and submit accurate printed and electronic copies to the SDO-Personnel Section on or before April 03, 2024. This data will be submitted to Philhealth Office for registration.
5. Rest assured that all data collected shall only be used for this purpose and shall adhere to Data Privacy Act of 2012.


