For services rendered on holidays, Saturdays and Sundays, identified testing coordinators, school heads, and division personnel are entitled to Compensatory Time-Off (CTO) or Certificate of Compensatory Overtime Credit (COC) in accordance with Civil Service and DBM Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Service Rendered and DO 13, s. 2024 on the Revised Guidelines on the Grant of Vacation Service Credits for Teachers.
- 5. Food, transportation and other incidental expenses of the testing personnel and support staff shall be chargeable against NASBE Fund subject to the usual accounting and auditing rules and regulations.
