LEARNER-PARTICIPANTS TO ATTEND THE SCHOOL ASSESSMENT AND CERTIFICATION SUPPORT PROGRAM OF THE JOINT MEMORANDUM CIRCULAR (JMC) SENIOR HIGH SCHOOL-TESDA CIRCULAR NO. 45 S.2024

1.
