- To strengthen the implementation of Adopt-a-School Program through sustained partnership and in support to schools' programs, projects, and activities, the Schools Division of South Cotabato shall designate Division Alternate Partnership Focal Person and District Partnership Coordinators effective immediately until revoked.

- d. Prepare final draft of partnership proposals for recommendation to the SDS,
- e. Prepare final draft of Memorandum of Agreement (MOA) / Memorandum of Understanding (MOU) for recommendation to the SDS,
- f. Finalize write up and provide updates to stakeholders on the status and progress of programs and projects to provide feedback and generate continuous support,
- g. Prepare and submit report on programs supported by stakeholders (existing and new ones) to the management of the schools division as feedback on the progress and status of the programs as well as the resource requirements of school,
- h. Prepare and provide Final Report of Accomplishment of Programs supported by stakeholders to provide feedback and generate continuous support.
- i. Monitor and ensure implementation of policies, standards, and guidelines for outcomes-focused resource mobilization to maintain the integrity and credibility of the schools division to its partners and stakeholders,
