> ESTABLISHMENT OF A HEALTH AND SAFETY OFFICER OF THE DAY IN THE SCHOOLS DIVISION OFFICE FOR CALENDAR YEAR 2025

To: Assistant Schools Division Superintendent Chief Education Supervisors Education Program Supervisors Public Schools District Supervisors/Principals In-Charge Public Elementary and Secondary School Heads Unit and Sections Heads All Others Concerned

1. In reference to DepEd Order 93, s. 1991 titled, **Addendum to DECS Order No. 63, s. 1989 on the Revitalizing the School Health and Nutrition Programs**, the School Governance and Operations Division (SGOD) through the School Health Section (SHS) is responsible in the coordination and effective implementation of health and nutrition programs and projects at the division level. Hence, the SGOD-SHS is directed to initiate staff monitoring and physical examination activities and conduct lectures to promote and ensure good health of all personnel, thus, improving their competencies and quality of living in the workplace.

2. Anent this, the SGOD-SHS shall establish a policy on creating a **Health and Safety Officer of the Day** from the field nurses to ensure that there shall be a **Nurse on Duty** in the Schools Division Office (SDO) Clinic from Monday to Friday. This is to augment in the occasional absence of our division nurses during various field works and activities as the designated program holders of the different flagship programs of the department in addition to their major role as clinic nurses in the field.

3. Please refer to the enclosure for the daily schedule of nurses for the month of January until June arranged alphabetically except for the five division nurses who shall take all the Monday schedules in line with their requirement to attend the Flag Raising Ceremonies in the SDO every Monday.

4. These are the roles and responsibilities expected from the Health and Safety Officer of the Day.

a. Monitor the blood pressure (BP) and other vital signs of identified personnel with known medical conditions, hypertension, diabetic mellitus (DM), hyperlipidemia and stroke cases and refer those with remarkable findings to the Medical Officer.

b. Provide immediate assessment, first aid treatment and management, along with the Medical Officer during emergency situations.

c. Take the basic information e.g. name, age, sex, address and vital signs of all patients and document the information privately in the Medical Consultation Logbook in accordance with the Data Privacy Act.

d. Assist the Medical Officer with any outpatient procedures to be conducted in the SDO clinic.

4. Observance of the minimum health standards and protocols set by the Department of Health shall be observed during the performance of duties.

6. Immediate dissemination of this memorandum is directed.
