1. In line with DepEd Memorandum No. 063, s. 2024 titled, 2024 Accreditation and Equivalency (A&E) Test Registration and Administration Guidelines, this office in coordination with the Division Testing Coordinator and Curriculum Implementation Division (CID) announces the conduct of **Division-Wide Monitoring on the Administration of 2024 Accreditation and Equivalency (A&E) Examination for the Elementary and Junior High School Learners of Alternative Learning System (ALS)** in the different identified examinations centers of South Cotabato on February 1-3, 2025.

2. The A&E Test aims to measure the competencies and life skills of ALS Learners. This assessment shall allow the learners to obtain certification of completion at different exits in Basic education which may be used to access further education, job promotion, entry to job training, and employment per DepEd Order No. 55, s. 2016 or the Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program.
