CREATING THE PROPERTY APPRAISAL AND DISPOSAL COMMITTEE

To: Division Executive Committee (DEXeCom) Members
Public Schools District Supervisors/Principals In-Charge
Public Elementary and Secondary School Heads
School Administrative Officer II
All Others Concerned

- 1. It is declared policy of the State that all resources of the government shall be managed, expended or utilized in accordance with laws and regulations, and safeguarded against loss or wastage through illegal or improper disposition, with a view to ensuring efficiency, economy and effectiveness in the operations of government. The responsibility to take care that such policy is faithfully adhered to rests directly with the chief or head of the government agency concerned.
- 2. That the Commission On Audit Circular No. 2020-006 dated January 31, 2020 sets forth the guidelines and procedures on inventory taking recognition of those found at station and disposition for non-existing/missing property, plant and equipment (PPE) items for one-time cleansing of PPE accounts of government agencies to establish PPE balances that are verifiable as to existence, condition and accountability, which shall be conducted by an Inventory Committee created by the Head of Agency for the purpose.
- 3. The provision under Title V of COA Circular No. 92-386 established the general policy, procedures and systems governing disposal activities or the proper disposition of government property that are unserviceable, obsolete, confiscated/forfeited/seized, abandoned, excess or surplus to its needs, or junk/scrap materials and equipment.
- 4. The Schools Division Office of South Cotabato Property and Supply Section is one such responsibility primarily of the government properties of the division.
- 5. Anent this, the Schools Division Office of South Cotabato creates Appraisal and Disposal Committee. The following are as follows:
