1. In reference to **DM-OUOPS-2025-11-01288**, this office is requiring all elementary and secondary schools to conduct a classroom-based learning session against online sexual abuse or exploitation of children (OSAEC) and Child Sexual Abuse or Exploitation Material (CSAEM) through integrating in the appropriate subject area.
2. This activity is relative to the celebration of Safer Internet Day, in compliance with the Presidential Proclamation No. 417 and Republic Act No. 11930 entitled "An Act Punishing Online Sexual Abuse or Exploitation of Children (OSAEC) and Anti-Child Sexual Abuse or Exploitation Materials (CSAEM).
3. These learning sessions will directly reach the learners, equipping them with knowledge and tools and increasing their awareness against OSAEC and CSAEM. The session guides can be accessed through this link: <https://tinyurl.com/2025AntiOSAECDraft>.

5. All instructional classroom-based sessions shall be conducted for each key stage and shall be delivered by the class advisers during their Homeroom Guidance or Edukasyon sa Pagpapakatao (ESP) subject. This classroom-based learning session shall be delivered during any day of **March**.
6. To ensure the effectiveness and efficiency of the conduct of the said activity, the different governance level is expected to answer the data collection forms. Accordingly, in compliance with the Data Privacy Act, teacher-designates and guidance advocates who will be handling learner disclosure are requested to fill out the non-disclosure agreement.
