DIVISION MEMORANDUM

**DIVISION-WIDE CONDUCT OF THE ALTERNATIVE LEARNING SYSTEM (ALS)
ADVOCACY AND COMMUNITY LITERACY MAPPING FOR SCHOOL YEAR 2025-
2026**

To: Public Schools District Supervisors/Principals In-Charge
Public Elementary and Secondary School Heads
All Others Concerned

1. In cognizance to the promotion of the right of all citizens to quality education at all levels and to take appropriate steps to make education accessible to all, the Curriculum Implementation Division shall conduct an **Alternative Learning System (ALS) Advocacy and Community Literacy Mapping (CLM) from May 21 to June 14, 2025**. This division initiative shall engage the participation of the Barangay Officials to assist in the mapping.
2. The Alternative Learning System (ALS) Advocacy and Community Mapping is in adherence to the Republic Act. No.11510, known as the Alternative Learning System (ALS) Act. This act aims to institutionalized and strengthen the ALS program, providing educational opportunities for out -of- school children and adults, including marginalized groups and indigenous peoples. It is also an avenue to promote lifelong learning opportunities and elevate socio-economic status, raise the level of literacy and contribute to individual's sustainable future; and to determine the number of Out- of-School Youths (OSYs) and Out – of School -Youths and Adults (OSYAs) who need basic education and literacy.

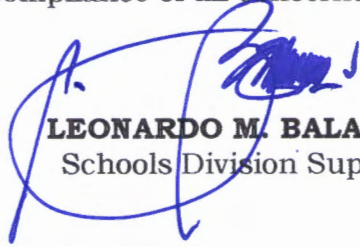
