CREATION OF THE 2025 SCHOOLS DIVISION OFFICE ELECTION TASK FORCE IN CONNECTION WITH THE NATIONAL AND LOCAL ELECTIONS ON MAY 12, 2025

To: Assistant Schools Division Superintendent SGOD and CID Chiefs Public Schools District Supervisors/Principals In-Charge Public Elementary and Secondary School Heads All Others Concerned

1. Pursuant to DepEd Memorandum No. 037, s. 2025 on the Creation of the 2025 Department of Education Election Task Force in Connection with the National and Local Elections on May 12, 2025, the **Election Task Force (ETF) Operations/Command Center** shall be operational at the Schools Division Office level from May 11, 2025 (1:00 p.m.) until May 13, 2025 (5:00 p.m.).

2. The said command center shall be responsible for monitoring and responding to election related concerns of this division. It also aims to provide technical and legal assistance to issues and concerns encountered by public school teachers and other personnel in the performance of their duties as Electoral Board members who will serve in the election.

7. Public Schools District Supervisors/PICs and school heads are directed to report immediately to the SDO ETF all incidents involving DepEd personnel serving during election polls and/or election related incidents through this link: **https://bit.ly/SoCotNLE2025** 

7. To ensure preparedness and smooth flow of the operations, the SDO Office Election Task Force Members shall have a deployment orientation on **May 11**, **2025; 1:00 p.m., at the SDO Conference Hall.** 

8. ETF Members and staffs shall be guided on time in time out policies and guidelines on overtime services during the conduct of the operation. All concerned personnel shall log their attendance on assigned time. The time of attendance shall be discussed during the deployment orientation.

9. All SDO ETF members and staffs shall be entitled to honoraria or overtime pay in compliance with the applicable issuances of the Commission on Audit and Department of Budget and Management, chargeable against Program Support Funds/Local Funds/Division MOOE, subject to the approval of the ETF
