# A RESOLUTION TO AWARD THE SUPPLY AND DELIVERY OF TONER TN118 TO PHILIPPINE DUPLICATORS INC. VIA DIRECT CONTRACTING AND RECOMMENDING FOR THE APPROVAL OF THE HEAD OF THE PROCURING ENTITY (HOPE)

**RESOLUTION NO.: 2023-10-055** 

WHEREAS, the Supply office of the Department of Education, Schools Division of South Cotabato requested for the procurement of Supply and Delivery of Toner Toner MP2014HS and Ink Copy Printer DX2430 (DSC-23-10-133) with the approved budget for the contract (ABC) amounting to Forty-Nine Thousand Pesos (PhP 49,000.00);

**WHEREAS**, the proponent of the project presented documents and informed the Bids and Awards Committee that said items can only be procured from the exclusive distributor, **Philippine Duplicators Inc.** with office address at CCC Bldg., Edison Avenue, Km 14, West Service Road, Brgy. Merville, Paranaque City;

**WHEREAS**, the BAC, upon careful deliberation and evaluation of the presented documents determined that the aforementioned project be procured through Direct Contracting since **Philippine Duplicators Inc.** is the exclusive distributor;

**WHEREAS**, Section 50 of Republic Act No. 9184, allows the procurement of the following:

- a) Procurement of Goods of proprietary nature which can be obtained only from the proprietary source, i.e. when patents, trade secrets, and copyrights prohibit others from manufacturing the same item;
- b) When the procurement of critical components from a specific supplier is a condition precedent to hold a contractor to guarantee its project performance, in accordance with the provisions of its contract; or
- c) Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GoP.

**WHEREAS**, the BAC thru its Secretariat requested **Philippine Duplicators Inc.**, to submit quotation and documentary requirements;

**WHEREAS**, **Philippine Duplicators Inc.** has complied with the requirements and conditions under Section 50. Direct Contracting and Appendix A of Annex H of RA 9184 and its IRR;
