WHEREAS, the SGOD-HRD, Department of Education, Schools Division of South Cotabato, requested for the procurement of Lease of Venue with Meals, Snacks and Accommodation for the conduct of HRDS Monitoring and Review of the conduct of PD Programs on December 15, 2023 (Live-In). (DSC-23-10-134) with the approved budget for the contract (ABC) amounting to Fifty-Seven Thousand Pesos (Php 57,000.00);

**WHEREAS**, the Schools Division Superintendent approved the conduct of such activity which requires leasing of venue including accommodation, meals and snacks;

**WHEREAS**, the BAC, upon careful deliberation and evaluation of the submitted price quotation, found the offer of **Sa Balai Lake View Resort** as the single calculated and responsive quotation detailed as follows;
