WHEREAS, the Department of Education, Schools Division of South Cotabato, SGOD-HRD, requested for the procurement of Lease of Venue with Meals, Snacks and Accommodation for the conduct of Coaching and Monitoring Program for NQESH Aspiring School Heads on December 1-2, 2023 (Live-In) (DSC-23-11-166) with the approved budget for the contract (ABC) amounting to One Hundred Twenty Thousand Pesos (Php 120,000.00);

**WHEREAS**, the Schools Division Superintendent approved the conduct of such activity which requires leasing of venue including accommodation, meals and snacks;

**WHEREAS,** Section 53.10 of the Revised implementing Rules and Regulations (IRR) of RA 9184 allows the procuring entities to resort to negotiated procurement for leasing a privately-owned venue for official use;

**WHEREAS**, the BAC received only one (1) quotation and opened the same on November 22, 2023, 10:00 am;

**WHEREAS**, the BAC, upon careful deliberation and evaluation of the submitted price quotation and compliant with the requirements, found the offer of **Sa Balai Lake View Resort** as the single calculated and responsive quotation detailed as follows;
