WHEREAS, the Department of Education, Schools Division of South Cotabato, CID-ALS requested for the procurement of Lease of Venue with Meals, Snacks and Accommodation for the conduct of Upskilling of ALS-SHS Teachers on December 2 - 4, 2023 (Live-In) (DSC-23-11-170) with the approved budget for the contract (ABC) amounting to Three Hundred Forty Thousand Pesos (Php 340,000.00);

WHEREAS, the Schools Division Superintendent approved the conduct of such activity on November 14, 2023 which requires leasing of venue including meals and snacks;

WHEREAS, Section 53.10 of the Revised implementing Rules and Regulations (IRR) of RA 9184 allows the procuring entities to resort to negotiated procurement for leasing a privately-owned venue for official use;

WHEREAS, the Bids and Awards Committee (BAC) thru its Secretariat invited three (3) hotels/venues of known qualifications to submit quotations;

WHEREAS, the BAC received only one (1) quotation and opened the same on November 23, 2023 10:00 am;

WHEREAS, the BAC, upon careful deliberation and evaluation of the submitted price quotations, found the offer of **Gensan Greenleaf Hotel and Development Corporation** compliant with the requirements as a service provider with the single calculated and responsive quotation detailed as follows;
